# ANDI-CO AUSTRALIA PTY LTD WARRANTY FOR HOUSEHOLD APPLIANCES.

## LA CORNUE - 10 YEAR WARRANTY ON RANGE COOKERS (promotion period 1st June to 2nd July 2023 inclusive), 5 YEAR WARRANTY ON RANGEHOODS

Andi-Co Australia Pty Ltd - 1 Stamford Rd, Oakleigh, Vic 3166

1) Andi-Co Australia Pty Ltd guarantees the equipment against defective material or faulty manufacture when used for domestic purposes for a period of FIVE (5) years from the date of purchase by the original Purchaser (LA CORNUE RANGEHOODS) and TEN (10) years from the date of purchase by the original Purchaser (LA CORNUE RANGE COOKERS purchased between 1st June 2023 and 2nd July 2023). All LA CORNUE cooking appliances must be installed by a qualified electrician or plumber where applicable. Failure to produce documentary proof of approved installation may negate the warranty.

2) Any complaints with regard to the state, the presentation or the non-compliance of our goods should be addressed to our headquarters by recommended letter with acknowledgement of receipt within a maximum of eight days following delivery

3) To the extent permitted by law, where the appliance the subject of a warranty claim is used or installed outside the capital city metropolitan area or the normal service area of an Authorised Service Agent or Andi-Co Australia Service Centre, the cost of delivery to the nearest Service Division or Authorised Service Agent shall be for the account of the Purchaser.

4) Risk in regard to appliances to be repaired shall at all times remain with the Purchaser.

5) This guarantee is given on the condition that the appliance to which it applies is used for the purpose and in the manner intended by its construction and for no other purposes whatsoever.

6) Andi-Co Australia Pty Ltd shall not be responsible for damage of any kind resulting from but not limited too; accidents, power surges, electrical storm damage, incorrect power and / or gas supply, infestation (vermin or insect), incorrect installation, electricity or plumbing installation, improper use of controls or failure to use the appliance in accordance with the operating instructions and from general misuse or abuse.

7) Any attempt by an unauthorised person to repair or tamper with the equipment shall render the guarantee null and void.

8) This guarantee does not apply to light bulbs, filters, fuses or to items where length of life depends on the extent of use and care given.

9) This guarantee is given on condition that the Purchaser takes all reasonable precautions in preserving the equipment and ensures the same is kept and maintained in good working order and condition.

10) This guarantee shall be available only to the original Purchaser of LA CORNUE household appliances from an Authorised Agent in and where the appliance has been retained for use in Australia.

11) Failure to produce documentary proof of the date of original acquisition by the original Purchaser will result in a charge being levied for work done, travel expenses, labour and parts supplied. Likewise, a charge will be made for any calls following warranty claim where no fault is found with the appliance

12) To the extent permitted by law, Andi-Co Australia Pty Ltd's liability under this guarantee is limited to the replacement and/or repair of the defective parts within the guarantee period. The replacement of the parts will not extend the guarantee set out above and does not extend to installation or removal of the appliance and the acceptance of liability by Andi-Co Australia Pty Ltd contained herein is to the exclusion of any other remedy whatsoever and howsoever arising in respect of any equipment to which it applies.

13) We take great care in the creation of our enamelled items. However, a hand-crafted enamel surface is never completely even and slight variations in shade may occur. This is a guarantee of quality and is linked to the nature of our enamelling process

14) Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

The benefits given to you by this warranty are in addition to your other rights and remedies under a law in relation to the goods or services to which the warranty relates.

15) Exclusions and limitations to the warranty. The current contractual warranties of The Company LA CORNUE and Andi-Co Australia Pty Ltd including its civil liabilities applying to its products will be limited to the reparation or replacement of any part or product deemed non-compliant within the conditions set out above. In any case, no claim regarding the conformity or a defect of a product will suspend payment of the said product. The warranty on defects will not apply if the cause of faulty functioning is: - Intervention on a product without prior consent of The Company LA CORNUE or Andi-Co Australia Pty Ltd; - Regular use of the product, negligence or lack of maintenance; - Force majeure In any of these three situations, The Company LA CORNUE and Andi-Co Australia Pty Ltd will be exempt of any civil liability. The Company LA CORNUE Andi-Co Australia Pty Ltd will not be held liable regarding the consequences of the use of the products it sells and will not under any circumstances be held responsible for damages, direct or indirect, material or immaterial, caused by the use of its products.
